(“the Buyer”), implementing the Bosnia and Herzegovina Governance Accountability Project, Phase II (hereinafter GAP) under the USAID Contract No. 168-C-00-08-00001-00 is soliciting proposals from eligible and responsible firms (“the Offerors”) for the supply of GIS software and spatial data-base to the selected GAP Partner Municipalities.

This project is funded by the Embassy of the Kingdom of the Netherlands, the U.S. Agency for International Development, and the Swedish International Development Co-operation Agency under U.S. Agency for International Development Contract No. 168-C-00-08-00001-00. In cooperation with Governance Accountability Project (phase2), GAP partner municipalities have developed a set of activities for improving its urban procedures. Use of GIS software and spatial data-bases shall assist in process of establishing the permit centers in which urban permits can be delivered in a transparent, user-friendly and expedient manner. In particular, GAP is soliciting proposals for supply of the following:

- LOT 3: ArcMap - ArcView 9.3. for 4 municipalities**
- LOT 4: GIS client/server software for 11 municipalities**
- LOT 5: GIS and Application Software for Cadastre in the Municipalities Posušje and Tomislavgrad**
- LOT 6: GIS system for the Municipality of Sanski Most**
- LOT 7: GIS system and services for development of GIS in the Municipality of Teslić**
- LOT 8: Data base for GIS – Basic for 1 municipality**
- LOT 9: Data Base for GIS – Standard for 11 municipalities**
- LOT 10: DataBase for GIS - Enterprise for 13 municipalities**
